You do not need to have project management experience to be a member of the Qualification Panel, but this would be an advantage.

Please note that you cannot be a member of the Qualification Panel if:

- you are affiliated with any APM Accredited Training Providers;
- you are currently involved in the development or delivery of project management qualifications for another awarding organisation; or
- if you are employed by an awarding organisation which delivers project management qualifications.

#### Time commitment

We are offering panel membership for 2 years in the first instance, with the possibility of extending up to a maximum of 4 years.

Panel members will be expected to:

- attend 2-hour quarterly meetings, which will take place via Microsoft Teams
- complete additional activities, which may take up to 2 days per quarter. These will be completed remotely, and timing can be flexible to fit around other commitments.
